("BELS"), Basswood Enhanced Long Short GP, LLC, Basswood Partners, L.L.C. and Basswood Capital Management, L.L.C. (collectively, the "Reporting Persons"). Basswood Capital Management, L.L.C. is the investment manager or adviser to BFF, Inc., BOP, BELS, Basswood Financial Fund, LP ("BFF"), Basswood Financial Long Only Fund, LP ("BFLOF") and Basswood Opportunity Fund, Inc.
