BCM is the investment manager or adviser to Basswood Financial Fund, Inc. ("BFF, Inc."), Basswood Opportunity Partners, LP ("BOP"), Basswood Enhanced Long Short Fund, L.P. ("BELS"), Basswood Financial Fund, LP ("BFF"), Basswood Financial Long Only Fund, LP ("BFLOF") and Basswood Opportunity Fund, Inc. ("BOF") (collectively, the "Funds") and certain separate managed accounts managed by BCM (the "Managed Accounts") and may be deemed to have a pecuniary interest in the Common Stock directly held by the Funds and held in the Managed Accounts.
