Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of the Director of Financial Reporting, the Director of Human Resources, and members of the Executive Services Team at Solium each acting individually, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
